NOTICE TO THE APPELLANT/DEFENDANT OR ATTORNEY

Red Light Appeals. Upon filing the Appeal, a Case Management Order will be issued by the Court directing the Philadelphia Parking Authority/City of Philadelphia to file the official record which consists of the Notice of Violation issued pursuant to 75 Pa.C.S. § 3116 and related documentation.

A de novo (new evidentiary) hearing will be scheduled.

Impoundment Appeals. Upon filing the Appeal, a Case Management Order will be issued by the Court directing the Philadelphia Municipal Court Traffic Division and the Philadelphia Parking Authority to file the official record which consists of copies of the Traffic Division order, the Live Stop Towing Report and related documentation, the Impoundment notices, and a copy of the Petition seeking leave to sell the impounded vehicle, if filed. ***The Appeal will be scheduled for a hearing by the Court limited to the issue of whether the impounded vehicle should be released, consistent with 75 Pa.C.S. § 6309, 6309.1 or 6309.2, and whether the release should be contingent upon the payment of all or part of the outstanding fees, fines and costs owed by the owner or driver of the impounded vehicle.***
