**ORDER**

AND NOW, this 26th day of October, 2011 consistent with Joint General Court Regulation No. 2008-01 and the Court Order dated July 17, 2008, Conciliation Conferences required by JGCR No. 2008-01 having been scheduled but not concluded, IT IS HEREBY ORDERED, ADJUDGED and DECREED that the Sheriff of Philadelphia postpone at the Court's direction those cases on the attached list which are currently scheduled for Sheriff Sale on November 1, 2011 to the January 2012 Sheriff Sale which shall be held on January 10, 2012 or to a subsequent Sheriff Sale date as may be requested by the Plaintiff.

IT IS FURTHER ORDERED and DECREED that the Sheriff Sale of any properties in which a Conciliation Conference has been held and concluded shall be postponed, at the Court's direction, to the Sheriff Sale date identified in the Order issued at the conclusion of the Conciliation Conference or, if no date is identified in that Order, to the January 10, 2012 Sheriff Sale or to a subsequent Sheriff Sale date as may be requested by the Plaintiff. At the November 1, 2011 Sheriff Sale, Plaintiff's attorneys shall provide to the Sheriff, if requested, a copy of any order issued at the Conclusion of the Conciliation Conference to assure compliance with this provision.

The Court having determined that the January 2012 Sheriff Sale was incorrectly advertised for January 3, 2012, IT IS FURTHER ORDERED and DECREED that all cases currently scheduled for or postponed to the January 3, 2012 Sheriff's Sale are postponed by the Court, as authorized by Pa.R.C.P. No. 3129.3(a) to January 10, 2012 without requiring new notice to be given by the Plaintiffs on the writ of execution. This postponement shall not be considered a voluntary postponement pursuant to Pa.R.C.P. No. 3129.3(b) and the delay caused by the postponement shall not be counted for purposes of computing the one hundred and thirty (130) days allowed for postponement pursuant to Pa.R.C.P. No. 3129.3(b).

The Sheriff of Philadelphia shall read the within order to the assembled bidders at the November 1, 2011 and December 6, 2011 regularly scheduled Sheriff's Sales and shall post a copy of this order prominently in the Office of the Philadelphia Sheriff.
