
ORDER

AND NOW, this 1st day of December, 2011 consistent with Joint General Court Regulation No. 2008-01 and the Court Order dated July 17, 2008, Conciliation Conferences required by JGCR No. 2008-01 having been scheduled but not concluded, IT IS HEREBY ORDERED, ADJUDGED and DECREED that the Sheriff of Philadelphia postpone at the Court's direction those cases on the attached list which are currently scheduled for Sheriff Sale on December 6, 2011 to the February 2012 Sheriff Sale which shall be held on February 7, 2012 or to a subsequent Sheriff Sale date as may be requested by the Plaintiff.

IT IS FURTHER ORDERED and DECREED that the Sheriff Sale of any properties in which a Conciliation Conference has been held and concluded shall be postponed, at the Court's direction, to the Sheriff Sale date identified in the Order issued at the conclusion of the Conciliation Conference or, if no date is identified in that Order, to the February 7, 2012 Sheriff Sale or to a subsequent Sheriff Sale date as may be requested by the Plaintiff. At the December 6, 2011 Sheriff Sale, Plaintiff's attorneys shall provide to the Sheriff, if requested, a copy of any order issued at the Conclusion of the Conciliation Conference to assure compliance with this provision.
